Muqadema (“we,” “our,” or “us”) is committed to protecting your privacy. This Privacy Policy explains how your personal information is collected, used, and disclosed by Muqadema.

This Privacy Policy applies to our website, and its associated subdomains (collectively, our “Service”) alongside our application, Muqadema. By accessing or using our Service, you signify that you have read, understood, and agree to our collection, storage, use, and disclosure of your personal information as described in this Privacy Policy and our Terms of Service.

Our Services

When you order one of our products, we will ask for personal data like your name and contact details. This data will be used to fulfill and complete your order. This data will be stored on a secure server owned by muqadema.com or by a third party. We will not combine your personal data with other data.

Communication

When you send emails or other messages to us it is possible that we will save those messages. Sometimes we will ask some additional personal information, but only when relevant. This is always to enable us to answer your questions and requests. This additional data will also be stored on a secure server owned by muqadema.com or by a third party.

Cookies

We collect data for research to get a better insight in our clients to tailor our products and services.

This website uses cookies. A cookie is small amount of data generated by a website and saved by your web browser. It is used to identify your browser, provide analytics, remember information about you such as your language preference or login information. Every time the user loads the website, the browser sends the cookie back to the server to notify the website of the user’s previous activity. This information gathered by the cookie will be stored on the security server of muqadema.com or by a third party.

We collect and use this information for no other purposes than described in our private policy unless we have your explicit permission to do otherwise.

Most browsers are set up to accept cookies, but you can set up your browser to refuse cookies or to notify you when a cookie is being sent to you. It is however possible that some services and functions on our website and on other website do not function properly when you have switched off cookies on your browser.

Third Parties

We respect the confidentiality of your personal data. We will not provide your data to other parties. In some cases, your data will be shared internally to resolve an issue. refers to advertisers, contest sponsors, promotional and marketing partners.

We may engage trusted third party service providers to perform functions and provide services to us, such as hosting and maintaining our servers and the website, database storage and management, e-mail management, storage marketing or credit card processing.

Affiliates

We may disclose information (including personal information) about you to our Corporate Affiliates. For purposes of this Privacy Policy, "Corporate Affiliate" means any person or entity which directly or indirectly controls, is controlled by or is under common control with Muqadema, whether by ownership or otherwise. Corporate Affiliates will be treated by those Corporate Affiliates in accordance with the terms of this Privacy Policy.
